- Frank Gardner liked his trip to Florida where, among other things, he attended the PGA Player's Golf Championship in Ponte Vedra Beach.




• Chuck Moore had a wonderful time traveling to Atlanta to help his son celebrate his 34<sup>th</sup> birthday and

## Today's Program

Lori Ross introduced our guest speaker, Bill Dodd, California State Senator, District 3. Bill is a fifth generation Californian and lifelong Napa Valley resident

where he grew up on a small family farm. A graduate of Chico State, Bill went on to own and operate one of California's largest, full-service Culligan Water businesses and served in leadership roles in national and trade associations related to water. Bill served 14 years on the Napa County Board of Supervisors, followed by one term in the CA State Assembly. He was elected to the CA Senate in 2016. District 3 includes portions of Sacramento, Yolo, Napa, Sonoma Solano and Contra Costa Counties. During his current term he has taken a leadership role in water policy, environment protection, and investing in our state's future. He is a Rotarian from the Rotary Club of Napa, and a Paul Harris Fellow. He and wife Mary have five grown children and seven grandchildren with another on the way.

Bill opened by saying he's attended a lot of Rotary meetings and he liked the quality of our Rotary Grace.

In his years in government service, Bill has found that the further one gets from local government the work toward making progress gets harder. He believes California politics are currently too partisan. Fixing road maintenance is



an example of a topic where partisan politics shouldn't be necessary. He feels that Governor Jerry Brown has been 'the adult supervisor in the room' during his second term; keeping the legislative process moving forward. He has appreciated working with the Governor on his current budget proposal. Dodd mentioned his successful efforts with Assemblywoman Curry to obtain disaster funding in response to last year's devasting fires.

Dodd expressed his interest in furthering education particularly in early childhood education. He also is fighting the notion of fake news. He is working toward getting media literacy education programs into grades 1-12 by soliciting private donations. He pointed out a major concern to him is that the pipeline of new teachers in California has really shrunk; very few new students are getting into the credentialing program.



Dodd also offered comments on various topics including the need for a CA sports wagering policy; the State's high speed rail system; and lessons learned from the Orville Dam fiasco. He said he has never understood the benefit in the Governor's Delta tunnel's project. He also said he supports construction of the proposed Sites Reservoir.
